

**AMENDMENT NO. 9
 CONTRACT FOR MEDICAL SERVICES AND COVERAGE BETWEEN
 FLORIDA HEALTHY KIDS CORPORATION AND
 SOUTH FLORIDA COMMUNITY CARE NETWORK, LLC D/B/A COMMUNITY CARE PLAN**

This Amendment No. 9, entered into between the Florida Healthy Kids Corporation (“FHKC”) and South Florida Community Care Network, LLC d/b/a Community Care Plan (“Insurer”) amends the Contract No.: 2020-02 for Medical Services and Coverage between FHKC and Insurer (“Contract”).

WHEREAS, the Contract allows for amendments by mutual written consent of the Parties; and

WHEREAS, the Parties desire to amend the Contract as provided in this Amendment.

NOW, THEREFORE, in consideration of the mutual promises and agreements herein contained, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

1. Section 3-3-2, Premiums, is hereby revised by inserting the following language after the table therein:

Effective January 1, 2023, the premium paid to Insurer shall be as follows:

2. Except as expressly amended hereby, the Contract shall remain in full force and effect in accordance with its provisions.
3. This Amendment No. 9 sets forth the entire understanding between the Parties with regard to the subject matter of the Contract and supersedes all other agreements, negotiations, understanding, or representations, verbal or written, between the Parties regarding the Contract.
4. In the event of any conflict between the Contract and this Amendment No. 9, the terms of this Amendment No. 9 shall govern.

5. This Amendment No. 9 may be executed in counterparts, each of which shall constitute an original and all of which together shall constitute the same document.


