#### **AMENDMENT NO. 7**

# CONTRACT FOR MEDICAL SERVICES AND COVERAGE BETWEEN FLORIDA HEALTHY KIDS CORPORATION AND SIMPLY HEALTHCARE PLANS, INC.

This Amendment No. 7, entered into between the Florida Healthy Kids Corporation ("FHKC") and Simply Healthcare Plans, Inc. ("Insurer") amends the Contract No.: 2020-03 for Medical Services and Coverage between FHKC and Insurer ("Contract").

WHEREAS, the Contract allows for amendments by mutual written consent of the Parties; and WHEREAS, the Parties desire to amend the Contract as provided in this Amendment.

NOW, THEREFORE, in consideration of the mutual promises and agreements herein contained, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

1. Attachment A: Benefit Schedule, Value-Added Services, is amended by deleting the Healthy Behaviors Program and replacing it as follows:

### **Healthy Rewards - Healthy Behaviors Program**

Insurer shall provide incentives to Enrollees for achieving health goals and attending appropriate and timely medical appointments across six (6) areas: well-child visits, weight management, smoking cessation, alcohol and substance abuse treatment, maternity care and asthma management. Incentives shall be provided on gift cards selected by the members.

Incentives include the following:

- Well-child visits:
  - \$20 for one well-child visit
  - \$50 once an Enrollee has received all shots recommended for their age
  - \$20 for your child's flu shot
  - \$50 for your child's HPV shot
- · Weight management:
  - \$50 Meet with a provider two times and choose a support group
  - \$50 Follow plan of care for 3 months, gain/lose 4 lbs per care plan, keep food log, visit your provider
- Smoking Cessation:

- \$50 Visit PCP, choose quit using tobacco program, submit attendance certificate
- \$20 for remaining tobacco free for one (1) month, submit personal and PCP attestation form
- \$20 for remaining tobacco free for three (3) months, submit personal and PCP attestation form
- Alcohol and substance abuse treatment:
  - \$20 for each telehealth or in person visit with Behavioral Health provider for maximum of 6 times
- Maternity:
  - \$20 for exam during first trimester or within 42 days of enrollment
  - \$20 for attending at least six (6) prenatal visits
  - \$20 for attending a postpartum visit between 7 and 84 days after delivery
- Asthma:
  - \$20 for visiting your doctor for an asthma visit
  - \$20 for obtaining annual flu vaccine
  - \$50 for filling your asthma medication for 6 months

Enrollee Eligibility for all Programs: Must meet age and diagnostic criteria for each category

Additional Limitations: None

2. Attachment C: Performance Guarantees, PG-10: Independent Review Timeframes, is deleted in its entirety and replaced as follows:

Insurer shall ensure that Insurer's contracted IRO completes one hundred percent (100%) of independent reviews within the following timeframes:

- Standard Review: Ninety (90) Calendar Days
- Expedited Review: Seventy-two (72) hours

Reporting Frequency: Quarterly

<u>Financial Consequences</u>: two thousand five hundred dollars (\$2,500) per independent review completed outside the applicable timeframe.

## Calculation Methodology:

Timeliness of an independent review is determined by the latest acceptable
resolution date for the review, regardless of the date the review was actually
resolved. For example, an independent review for which the latest acceptable
resolution date falls in quarter B shall be calculated for quarter B regardless of
the quarter during which the review was resolved.

#### **Related Contract Reference: Section 23**

- 3. Except as expressly amended hereby, the Contract shall remain in full force and effect in accordance with its provisions.
- 4. This Amendment No. 7 shall be effective for Insurer's quarterly report due February 15, 2022.
- 5. This Amendment No. 7 sets forth the entire understanding between the Parties with regard to the subject matter of the Contract and supersedes all other agreements, negotiations, understanding, or representations, verbal or written, between the Parties regarding the Contract.
- 6. In the event of any conflict between the Contract and this Amendment No. 7, the terms of this Amendment No. 7 shall govern.
- 7. This Amendment No. 7 may be executed in counterparts, each of which shall constitute an original and all of which together shall constitute the same document.
