## **AMENDMENT NO. 9**

## CONTRACT FOR MEDICAL SERVICES AND COVERAGE BETWEEN FLORIDA HEALTHY KIDS CORPORATION AND SIMPLY HEALTHCARE PLANS, INC.

2. Attachment A: Benefit Schedule, Value-Added Services, is amended by deleting the Educational Tutorial Services and replacing it as follows:

## **Educational Tutorial Services**

Insurer shall offer up to twenty-four (24) hours per year of virtual, one-on-one tutoring services to Enrollees who are at risk of failing a grade in the following core subjects: reading, English, writing, math, science, and social studies (history and geography). Also includes SAT Prep classes. Study and organizational skills are taught within each core subject.

Enrollee Eligibility: Enrollees at risk of failing a grade; prior authorization required

Additional Limitations: twenty-four (24) hours per year

- 3. Except as expressly amended hereby, the Contract shall remain in full force and effect in accordance with its provisions.
- 4. This Amendment No. 9 sets forth the entire understanding between the Parties with regard to the subject matter of the Contract and supersedes all other agreements, negotiations, understanding, or representations, verbal or written, between the Parties regarding the Contract.
- 5. In the event of any conflict between the Contract and this Amendment No. 9, the terms of this Amendment No. 9 shall govern.
- 6. This Amendment No. 9 may be executed in counterparts, each of which shall constitute an original and all of which together shall constitute the same document.
